3. The Racing Team Meeting will take place April 25 at Wright Brothers Cyclery. USCF riders with QCW on their license and anyone considering becoming licensed are urged to attend. You can meet the other racers in the club and have input as to how sponsorship money will be spent.

4. The Spring Opener Time Trial will again be held on consecutive Tuesdays starting on May 1. USCF licensed riders will race May 1 while citizen racers will ride May 8. Included in this newsletter is a race entry form. The entry fee will include a T-shirt and prizes will be awarded.

5. We have decided to add some special events to the Tuesday Time Trial Series this year. July 3 will be reserved for two man teams. August 7 will be an out and back 20 mile time trial while September 4 will be a four man team time trial to prepare for the Louisville race.
